International Centre for Synchrotron-light for Experimental Science and Applications in the Middle East (SESAME) hereby invite qualified companies from the SESAME seat country (Jordan) to submit sealed tenders for:

Supply, delivery, testing and operating of the following solutions for SESAME's Datacenter, Beamlines, Guest House and Main Building:

- NGFW with high availability.
- Active networking.
- Passive networking components.
- Voice over IP (VoIP)

For the active network component, this tender is a "Cisco part number tender" due to the following facts:

- Some parts will be installed as expansion of the current running systems (i.e. Wifi APs).
- Some existing equipment will be integrated with the new system (IP telephony)
- All new devices and equipment will be installed and configured on the running network in SESAME which is Cisco based.
- For the security solution, SESAME needs a complete solution from one vendor including the main gateways, mail security, end clients and network identity service, which is already covered in Cisco solution.

For the passive components, bidders can submit their offers, which should be complying with the technical specs. This is also implied on the UPSs.

For the security cameras, bidders have to provide the needed cameras with the exact part number, as it will be installed as expansion of the current running system.

For quantities and more details please refer to the technical specifications.

The purpose of this notice is to provide general information on the requirements for the procurement process and to inform interested suppliers how to obtain a copy of the Solicitation Documents.

The sealed tenders must be delivered to SESAME on or before **8 April 2019 at 15:00 hours Jordan** Local Time, in strict compliance with the instructions as stipulated in the Solicitation Documents.
