1. **Replace the complete file of:**

2. **The deadline for receiving offers from bidders is extended until 9 May 2019, 15 :00 hrs. Local Jordan Time.**
3. **ITB document: Delete Article 5.1 and Replace it by:**

5.1 Clarification Meeting / Site Visit:

Site visit will be on **14 March 2019 and 14 April 2019 at 11:00 hr Jordan local time** to answer any questions on the tender documents which have been forwarded in writing or are raised during the site visit. Answers will be published on the website - together with any clarifications in response to written requests which are not addressed during the visit according to the below timetable. Visits by individual prospective tenderers during the tender period other than this site visit for all prospective tenderers are not allowed.

4. **ITB Document: Delete Article 6 and its related table and replace it by**

6. Amendments of Solicitation Documents: No later than **2 weeks prior to the Deadline for Submission of Bids**, the procuring entity may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, amend the Solicitation Documents. All prospective Bidders that have received the Solicitation Documents will be notified in writing of any amendments. In order to afford prospective Bidders reasonable time in which to take the amendments into account in preparing their offers, the procuring entity may, at its discretion, extend the Deadline for the Submission of Bids.

 - (e) If the bidder is not Jordanian, a proven explanation is required on how to proceed with the needed SLA and technical support onsite.
